Capital Punishment and Other Matters

Last May at the Annual Meeting, after thoughtful debate our members voted in favor of an amendment to a recommendation of the Council that § 210.6 of the Model Penal Code dealing with the death penalty be withdrawn. The exact language of the motion that passed, with some members abstaining, was:

For reasons stated in Part V of the Council's report to the membership, the Institute withdraws Section 210.6 of the Model Penal Code in light of the current intractable institutional and structural obstacles to ensuring a minimally adequate system for administering capital punishment.

At the October Council Meeting, a strong majority of the Council voted, with abstentions, to accept the motion passed by the membership in May, and it now becomes ALI policy. As with the meeting of the members in May, the Council discussion was appropriately serious and substantive.

Given the Council's interest, the Director and the Program Committee agreed to consider other criminal-law topics suitable for the Institute's attention. Council Affirms Membership Vote to Withdraw Capital Punishment Section from Model Penal Code

On October 23 the ALI Council voted to accept the resolution approved by the membership at the 2009 Annual Meeting to withdraw § 210.6, dealing with capital punishment, from the Model Penal Code. (For more information, including the exact wording of the resolution, see also the President's Letter on page 1.)

Having been approved by both the Institute's membership and its Council, this resolution is now the official position of The American Law Institute. The Council's vote brings to a conclusion more than two years of research, study, and discussion that began when Professors Roger S. Clark of Rutgers – Camden School of Law and Ellen S. Podgor of Stetson University College of Law moved at the 2007 Annual Meeting that the Institute take a position against the death penalty in connection with its work revising the sentencing provisions of the Model Penal Code.

At its meeting in New York on October 22 and 23, the Council also approved two Council Drafts for submission as Tentative Drafts to the membership at the 2010 Annual Meeting: §§ 8.01 through 8.08 of Chapter 8 of the Restatement Third of Employment Law, dealing with the employee's duty of loyalty (there was insufficient time to discuss the Chapter's last three sections), and certain proposed revisions to U.C.C. Article 9 on secured transactions.

The Council also reviewed Chapter 1 (Relationship Between the Charity and the State) of Reporter Evelyn Brody's draft for the Principles of the Law of Nonprofit Organizations. Professors George Bermann and Catherine Rogers, Reporter and one of the Associate Reporters for the Restatement Third, the U.S. Law of International Commercial Arbitration, presented Chapter 5, dealing with recognition and enforcement of arbitration awards, for the Council's discussion. In each case the Reporters received helpful feedback. The Council also approved the commencement of a new ALI project on ethics in government. (See article on page 5.)

In other business, the Council confirmed Director Lance Liebman's appointment of 31 Advisers to the International Commercial Arbitration project; their names are posted on the Institute's website, www.ali.org, under the "Projects" link.

Following longstanding custom, two new Council members were invited to make brief remarks to introduce themselves to their colleagues at the Council dinner on October 22. Derek P. Langhauser, General Counsel of the Maine Community College System, and Judge Elizabeth S. Stong of the U.S. Bankruptcy Court in Brooklyn accomplished their task with grace and humor.

To obtain suggestions of other law-reform topics the Institute might address, and to help our members understand the process by which we select projects, Judge Paul Friedman, Chair of the Program Committee, and Director Lance Liebman plan to host an early-morning gathering for interested members at our next Annual Meeting in May 2010 in Washington, D.C., at the Mayflower hotel. For those of you particularly interested in this meeting about project development, I hope you will put our Annual Meeting dates—May 17-19, 2010—on your calendar now. If you can't attend the entire Meeting, keep your eye on our website, where the agenda, with dates attached, will be posted by February.

In December the Council will review the final two chapters and the revised first chapter of the Restatement of Restitution and Unjust Enrichment, the superb work of our Reporter Andrew Kull and our first-rate Advisers and Members Consultative Group. If approved by the Council, these new sections will be a feature of the 2010 Annual Meeting, when the membership will have the chance to discuss the material and, I hope, to approve it. Meanwhile, Andrew is reviewing all previously approved chapters, with the expectation that he will have a revised manuscript of the whole by mid-2010. So far, he believes that his changes are editorial improvements within the boundaries of the Boskey Motion.* As they are not substantive or fundamental, they will not require additional review by the Council or by the membership at an Annual Meeting. However, Lance Liebman is exploring with Andrew the possibility of asking committed members to review his changes and also of posting the revised work for general comments. That way, we can assure that, notwithstanding editorial changes, the substance of the work remains accurate and clear. As we figure out an appropriate review process, we will advise you. What we don't want to do is delay the final publication of this important Restatement for another year.

I mention this work especially because litigators on our Council have made the point that many lawyers and judges would find the new Restatement terrifically helpful but may not appreciate the amount of practical guidance related to litigation to be found in it, because they may not normally think of Restitution in any number of commercial situations. If any of you are in that group, you will want to pay special attention to the e-mail we send to the membership proudly announcing the publication of Restitution Third.

This brings me to ask yet another question of you as members: Please let me know whether you would find interesting and useful a one- or two-hour web session with the Reporters on some of our projects as they near completion. Having heard some of the great discussions by our Reporters on Aggregate Litigation and Restitution, among other subjects, I have wished that all of you could benefit from those comments, and thought perhaps a webcast would be an efficient way to do that. We will soon send you an e-mail with a link to a brief Member Survey asking you this question and also containing a box for comments.

As you will see elsewhere (page 2), we have elected 68 new members in the last few months, and we look forward to the additional vigor they will bring to our activities. The serious problems

that our country faces have made the work of law reform at the highest levels ever more important. We hope soon to launch a new project on election law, our Principles of Nonprofit Organizations project continues to evolve, and Lance is working hard to help us define the right place for us to be helpful in the area of financial regulation.

We are proud to have a small but efficient staff that somehow manages to get our many meetings organized beautifully, keep up with multiple projects, and deal with all of the other issues that nonprofits face these days. Elena Cappella, our Deputy Director, announced in September that she will, after almost 20 years, be leaving the ALI at the end of the Annual Meeting, and we have all expressed our appreciation for her faithful and tremendously intelligent hard work.

As always, I look forward to hearing from you about substantive or organizational issues. We are a relatively small group, but our terrific combination of fine lawyers, great judges, and distinguished scholars working together continues to make American law better in many important ways. I thank each of you for taking the time to participate in our serious work.

* As many members know, the Boskey Motion, named for our Treasurer Bennett Boskey and customarily made by him, is the motion for approval of a draft made after the draft has been substantially debated. The motion is stated to be subject to two conditions: "subject to the discussion at the meeting, and subject to the usual editorial prerogative"; the latter condition means that flexibility is allowed for changes in language, arrangement, and style, but not changes in substance.

On October 22, 2009, the following Minute in Remembrance was read at the Council Meeting:

— MINUTE IN REMEMBRANCE —

James H. Wilson, Jr.

November 26, 1920 – April 18, 2009

On April 18 of this year we lost a fellow Council member, James H. Wilson, Jr., who had served with distinction for 34 years. He transferred to emeritus status in May of last year.

Jim's career was truly extraordinary. He was born in 1920 in the tiny town of Oliver, Georgia, the son of a Methodist minister. The birthplace could easily have been elsewhere, because Methodist Church policy required a minister to move to a different town every few years. But the rural background of his earliest years undoubtedly helped to shape Jim's personality.

His brilliance academically must have been evident in the course of his early schooling, because he entered Emory University at the age of 15. He graduated from Emory at the age of 19, at the top of his class and a member of Phi Beta Kappa. Upon graduation from Emory in 1940, he entered Harvard Law School. His first-year grades at Law School placed him No. 1 in his class. Halfway through his second year, in 1942, he enlisted in the U.S. Navy. In the Navy he became a lieutenant commander, serving on destroyers in both the Atlantic and the Pacific. His ship participated in major landings in the South Pacific, involving heavy combat action.

After the war, in 1946, Jim returned to Harvard Law School and continued his superlative academic performance. He was elected President of the *Harvard Law Review* and graduated summa cum laude and first in his class, thereby becoming the recipient of the Fay Diploma. Legend has it that his grade-point average was second only to that of Justice Louis Brandeis.

When he finished law school in 1947, Jim chose to enter private practice with

the law firm of Sutherland, Tuttle and Brennan—now Sutherland, Asbill & Brennan—rather than to clerk or teach. Jim became a partner six years later, in 1953, and remained a partner until his death. His practice focused on the corporate- and income-tax aspects of business transactions and included trial and appellate work in the tax field.

Within the Sutherland Asbill firm, the tributes and accolades to Jim and the articulated memories have been as warm and moving as one could possibly imagine. He was a revered leader of the firm and an exemplar for young lawyers. As one partner observed:

In the practice of law, Jim was truly a giant. He used his awesome intellectual and analytical abilities, as well as innate practicality, to produce persuasive legal arguments and solutions to complex tax and business problems—as well as handling appellate cases.

Jim became a member of the ALI in 1958, at the age of 38. Sixteen years later, in 1974, he was elected to the Council. In 1979 President Ammi Cutter appointed Jim as Chairman of the Finance and Development Committee. This led to my subsequent appointment of Jim as Chairman of the Capital Campaign Steering Committee. He did a splendid job in this capacity, and at the Council meeting of May 15, 1989, Jim announced that the Capital Campaign had raised approximately \$5,469,000, well in excess of its goal of \$5,000,000.

As for his service on substantive ALI projects, Jim was a member of what we then called the Tax Advisory Group—now the

Tax Program Committee—and he was actively involved in two Federal Income Tax Projects, one entitled Subchapter C: Proposals on Corporate Acquisitions and Dispositions, and one on Integration of the Individual and Corporate Income Taxes.

Jim also served for three years as a member of our 75th Anniversary Committee and, more recently, as a member of the Special Committee on Bylaws and Rules of the Council.

In 1975 President Ford's staff and legal advisers included Jim's name on a list of possible appointees to replace retiring Supreme Court Justice William O. Douglas. Although the ultimate choice was John Paul Stevens, the recognition was an honor and a testament to Jim's legal career and reputation.

In addition to his service to the ALI, Jim gave of himself to many organizations. His loyalty to Emory and to the Harvard Law School was unstinting. For Emory his service included President of the Alumni Association, Chairman of the Board of Visitors, and member of the Board of Trustees. For Harvard Law School he was a member of the Overseers Visiting Committee and the Alumni Council.

Jim also contributed mightily to the legal profession through active membership in the ABA's Tax Section and the American College of Tax Counsel. In 1963 and 1964 he served as a member of an Advisory Group appointed by the Commissioner of Internal Revenue. He was a Fellow of the American Bar Foundation.

Jim's civic service in Atlanta included the chairmanship of the Metropolitan Atlanta Crime Commission in 1970 and 1971. In 1992 he was given the Atlanta

New Project on Government Ethics Begins

On the recommendation of ALI Director Lance Liebman and the Program Committee, the ALI Council at its meeting in New York City on October 23 gave its approval for work to begin on a project encompassing principles of government ethics. Professor Richard Briffault of Columbia Law School will serve as the project's Reporter. Professor Briffault, a graduate of Columbia University and Harvard Law School who joined Columbia's faculty in 1983, has taught and written extensively on the law involving state and local governments, as well as on property law and election law.

According to the Reporter's prospectus, the project's purpose is to enunciate a set of principles or best practices that would both reflect the emerging law of government ethics and provide guidelines to shape its future development. The project will focus on standards applicable to the legislative and executive branches, and will exclude ethical issues unique to the judiciary. The project may address limited issues in the area of campaign-finance regulation. Specific topics proposed for inclusion are lobbying, gifts and other things of value given to public officials, conflicts of interest involving the private activities of public officials, the political uses of public office, and administration and enforcement mechanisms.

Jim was fun to be with on any occasion. His sly wit and sense of humor enriched our discussions. He was at all times unpretentious and unassuming. His gentlemanly style was admired and appreciated.

At the outset I characterized Jim's career as extraordinary, and I do so again. On behalf of the Council, I wish to pay particular tribute to his service to The American Law Institute and to express the warmth of our feelings toward a long-time colleague.

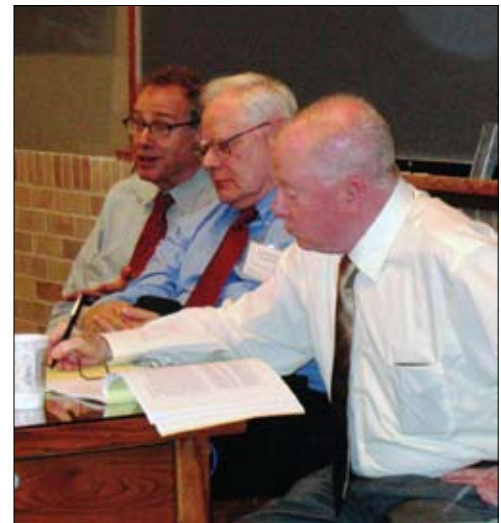
